Green Courts is pleased to submit our bid for the resurfacing of your tennis Courts. Our company has over 15 years of combined experience in hard court resurfacing. We specialize in attention to detail, quality, and superior customer service. Our work is guaranteed with a (2) year warranty.

The contractor hereby agrees to furnish all of the necessary materials, labor, equipment and tools to perform the following work to the stated specifications, and for the price stipulated:

Scope of Work: Resurface two (2) Asphalt Tennis Court(s) with a 4-coat system

Surface Prep: Pressure clean and power blow court as necessary to remove loose dirt & mildew. Patch depressions greater than 1/16” after 1 hour dry time, includes 2 large depressed areas. (*U.S.T.A STANDARDS*), grind down any ridges and fill existing cracks wider than 1/8” prior to surfacing. **Install fiberglass membrane strips on large cracks only as necessary.** Note: Court must have 1% slope to ensure proper removal of water.

Surfacing/Colorcoating: **Apply (2) Coats** of Acrylic Resurfacer
Apply (2) Coats of Color Concentrate (two-tone).
Stripe court with 2” wide lines in accordance with U.S.T.A regulations.
Sand & paint net posts

- Option I:** Install new Championship tennis net Add \$150.00/each ___#___
- Option II:** Install (1) new set of net posts Add: \$185.00/each ___#___
- Option III:** Install 6’ high PVC mesh windscreens on both courts, Add: \$2,195.00 ___
- Option IV:** Cut out 500 sq. ft. of root damage and replace asphalt add: \$1,375.00 ___

Terms & Conditions:

50% deposit upon acceptance, 25% delivery of materials & commencement, final balance upon completion.

The Customer will furnish safe access to site for equipment and material. The Contractor accepts no responsibility for acts by anyone at job site except for those sub-contracted or employed by Green Courts. Note: court must have a minimum of 1% slope in one plane in order to guarantee removal of water. The Contractor will clean up all drums, trash, etc. upon job completion.

If payment is not made as agreed herein, Customer agrees to pay interest at the maximum legal rate of (10%) per annum for individuals or (15%) per annum for corporations on the unpaid balance and further agrees to pay all court costs and reasonable attorney's fees, if incurred, in the collection of the account.

When signed by Customer and approved by GREEN COURTS, this becomes a non-cancelable contract and the Customer hereby agrees to pay the contract price according to the above terms. The price(s) quoted above are subject to change if not accepted within 30 days and/or if work may not be commenced within 60 days and completed in continuous manner.

Guarantee:

The Contractor guarantees all work against defects in workmanship or materials for a **period of (2) years** from date of completion. This guarantee excludes normal wear and tear, physical abuse or neglect and any other conditions beyond the contractor's control, such as sub-base settling, structural cracks, asphalt shrinkage cracks, hydrostatic pressure or water vapor pressure bubbles, intrusion of weeds or grass, etc. Proper tennis shoes must be worn on court. Some sneakers, street shoes, dark soled shoes, skateboards, roller blades, etc. will scuff and damage surface. Guarantee shall become void upon owner's failure to adhere and comply with the payment schedule.
